### **5. Reports of Committees**

#### **Sweepstakes Committee – Jeff Robbins, Shane Cunningham, Hunter Graybeal**

##### **Discussion:**

- A 2-year pilot program was implemented including all events, weighted equally (each area counted as  $\frac{1}{4}$ ).
- Trophies awarded only to the top team in each category.
- Miscommunication at the state tournament caused confusion about the intended structure.
- Concerns raised regarding equitable recognition for small schools.

**Motion 1:** To establish **four categories of sweepstakes**.

**Discussion:** Clarification requested on event weighting. Agreed to announce 1st–3rd places regardless of trophy awards.

**Vote:** 6 in favor, 3 opposed

**Discussion:**

- Congressional Debate had numerous issues at the previous state tournament.
- Committee presented updated rules and proposed each district provide a parliamentarian.

**Motion:** To approve the committee's recommendations on Congressional Debate as written.

**Vote:** 7 in favor, 1 opposed, 1 abstention

### **A. Doubling at State – Doug James**

**Proposal:**

## B. Theater Design Category Proposal – Doug James

### **Proposal:**

- Currently, Set and Costume Design are always combined at State.
- Suggestion to formally create a single “Design” category.
- Concerns noted that the two disciplines differ significantly.

**Motion:** To form a committee to review the proposal to combine Set and Costume into a single Design category.

**Vote:** 9 in favor, 0 opposed  
**Motion Carried.**
